The Nuix 7.6 release includes updates to Nuix Workstation, Nuix Web Review & Analytics, Nuix Enterprise Collection Center, and the underlying Nuix Engine. Within the release, we enhanced our processing speed, extended the industry-leading list of file types we process, enabled browsing and content targeting before collection, and improved search term reporting.

This release incorporates our customers' most requested features and maintains our position as the industry leader for file processing and analysis.

- **Law enforcement, government, and regulatory** investigators will be able to incorporate social media data into investigations without needing additional tools. We've also made it easier to cross-reference between mobile device forensic images from different vendors.
- **Corporate eDiscovery, legal, investigation, and information governance professionals** will find it easier to add, organize, and share information with outside counsel, regulators, third-party partners, and departments within and across cases. This gives you greater scale and control in managing large projects through production.
- **Advisory firms and service providers** can streamline their workflows by using new templates for processing settings, metadata imports, and legal export document numbering and load file settings. A structured and semi-structured data loader makes it easier to process productions from opposing counsel.



NEW FEATURES

NUIX WORKSTATION

- **New profiles.** For customers looking to maintain consistent processes over many data sets and cases, we've added profiles for processing settings, metadata imports, and legal export and load file settings.
- **Bulk evidence uploads.** This release supports uploading large numbers of evidence sources in batches using comma-delimited lists of files, folders, and other formats such as Amazon S3, Microsoft Office 365, and Microsoft SharePoint.
- **Structured and semi-structured data loader.** You now have the option to bulk add, update, map, and normalize metadata fields from Concordance load files, CSV, XML, JSON, and SQL databases. This streamlines the process of loading eDiscovery productions from opposing counsel into Nuix and has applications for importing transactional data, phone logs, door swipe logs, threat intelligence feeds, and more.
- **Normalized mobile image imports.** Mobile device images from Cellebrite, Oxygen Forensic, and XRY use their own property names, making it a nightmare to cross-reference between images from different vendors (for example, for dual-tool verification of the same device). This release standardizes the field names when they're imported into Nuix.
- **Performance improvements.** We've improved our speed for importing Microsoft SharePoint data and for processing large container files (such as 7Zip) and Amazon S3 buckets.
- **New file formats.** Nuix Workstation 7.6 now processes AutoCAD PIA files, AVCHD videos, DICOM files, GeoJSON files, Google Fit Training Center files, Google Hangouts conversations, Oracle databases and Virtual Box disk images, Shuriken 2018 mailboxes, Slack channels, users, and conversations, WhatsApp message and contact database files, and Xerox DocuWorks files.
- **Facebook and Twitter support.** Our latest release can import Facebook profile data in the format Facebook uses when responding to subpoenas and from live Twitter accounts.

- **File system browser.** You can remotely browse the contents of drives on endpoints across the network and specifically target selected volumes, folders, or files for collection.
- **Remote interactive command shell.** The ECC Client now allows you to execute remote commands on any computer. You can check free disk space, examine folders, collect individual files, and perform many other administrative tasks remotely.
- **Improved macOS and Linux support.** On macOS and Linux endpoints, you can now run Smart Mover, Deployment, and Relocation jobs.

- **Search term reports.** You can generate reports on search term hits including direct, unique, and family counts. These reports allow your team to interact directly with and hone the search results to determine and deliver on case strategy.
- **Simplified query builder.** We developed an intuitive query builder to give non-technical people the ability to build queries without knowing exact native query language.
- **Streamlined interface.** We've optimized the interface with tool buttons and pop-out panes to provide easier access to common tasks while reviewing evidence items in the grid view.
- **Back-end improvements.** The latest release includes multiple fixes behind the scenes to improve the reliability, performance, collaboration, and usability of the product.
